# Call to Order and Roll Call - Regular Meeting Chair Swanson called the meeting to order at 4:32 p.m. There was a quorum.

# 5. President's Report - Dr. Walt Tribley

- a. District Division Update Dr. Tribley reported that while federal funding for Adult Basic Education funding has been suspended, the state has allocated funds to allow the continuation of this program. Funds for GCCD will be transferred to Gillette College from Sheridan College.
- b. Science Building Update SC moving forward with level III design and seeking retroactive reimbursement for 55% of design costs from the State.
- c. General Updates SC received federal TRiO grant funding.

### 6. Johnson County Advisory Board Report

VP Smith highlighted a few of the courses offered at SCJC during the fall 2025 semester. She pointed out that a student can earn a degree without leaving Johnson County by taking in-person and online courses. She reported that Kaycee will host its first community interest course in printmaking this fall. She invited the Board to attend the JC fair "Sheep Feed" at JC Fairgrounds on Tuesday, 7/29 at 5pm.

### 8. Public Hearing for the Fiscal Year 2026 Budget

Chair Swanson opened the Public Hearing for the Fiscal Year 2026 Budget at 4:44 p.m. Dr. Tribley explained that VP Achord would discuss a significant change to the FY26 budget. VP Achord reported that the WCCC provided updated figures recently, which increased the operating revenue (see materials provided to the Board). Trustee Holloway asked why the revenue increased. VP Achord explained that auxiliaries were incorrectly included in the original funding formula calculation. Removing them made the fixed portion of the fixed and variable cost ratio increase. Chair Swanson asked the public if they had any questions or comments. There were none. Chair Swanson closed the Public Hearing and reconvened the Regular Board Meeting at 4:48p.m.

# 9. Fiscal Year 2026 Budget Adoption: Approval of Expenditure Authority Resolution and the Resolution to Provide Income – Action

Chair Swanson requested a motion to approve the budget and referred the Board to the figures provided in the materials given to the Board on 7-15-2025. Trustee Henry moved, and Trustee Cotton seconded. There was no further discussion. The motion carried.

# 10. Approval of Two (2) Expenditure Authority Resolutions

VP Achord explained that the two items are bonds, backed by Whitney Benefits, but required to be in the budget book and in a motion to be approved every year. Trustee Cotton moved to adopt the resolutions. Trustee Holloway seconded. The motion carried.

- a. Refunding and Improvement Lease Revenue Bonds: Mars Ag & Science Center and Whitney Center for the Arts in the amount of \$1,490,000.
- b. Refunding and Improvement Lease Revenue Bonds: Tech Ed Center in the amount of \$810,000.
